Minutes of a meeting of the Astronomical Society of South Africa
held at the residence of Mr A. W. Long, Camdeboo, Malleson Rd.,
Howick, at 8-15 pm. on Monday June 20th 1932

Present

Mr Schonegezel in the chair, Dr Spencer Jones, Messrs Andrews,
Burrell, Long, McIntyre, Pearcey, Pratt, Smith, Capt Cameron Swan
and the hon sec. An apology for absence was received from Mr
Mason who had left for Natal.

Minutes

The minutes of the previous meeting were read and confirmed.

Herschel Memorial. Mr Pratt submitted a plan of the school grounds
showing the position of the obelisk, and the extent of the area
reserved by Sir John Herschel, and the area fenced off enclosing
the obelisk. The area reserved is considerably greater than that
fenced off. Motion of thanks to Mr Pratt, proposed by Mr Long
and seconded by Capt Cameron Swan was passed.

The Secretary reported that information had been
received from the secretary of the National Society to the effect
that he had written to the City Council suggesting that the
transfer of the reserved land (as agreed to by the Claremont
Municipality in 1906) be registered. [letter to H.M. Astronomer].
He also read certain of the correspondence of the late Cape
Astronomical Association showing that the question of
right of way had been raised by them, and that the
Claremont Municipality had arranged for a right of way
from Obelisk Road to the Herschel Obelisk, by negotiation
with the Diocesan College Council. From inquiries that had
been made it appeared that the most advantageous procedure
would be to request that the Parks and Improvements
Committee receive a deputation which would lay the situation
before them.

On the proposal of Dr Spencer Jones seconded by Mr
Long it was agreed that a deputation be appointed to meet
the Parks and Improvements Committee to urge that the
City Council take transfer of the reserve in accordance with

be performed to and accepted by the Claremont Municipality in 1906; and also that advantage be taken of the right of way already secured, to make the memorial more accessible to the public than at present. Dr Spencer Jones, Mr Maitlyne, and the hon. Sec. were appointed to act, and it was agreed to invite the South African National Society and the Claremont Ratepayers Association to send representatives.

Correspondence. The hon. Sec. read a letter from the hon. Sec. of the Natal Astronomical Association stating that a motion ^{in favour of} ~~to enter~~ _{by the committee} the Society would be presented to their annual meeting.

Financial Statement. This showed a balance of £24-16-9. The discussion of the financial position of the Society led to the suggestion that it would be desirable for the next meeting of the Council to consider the bearing of the financial position on the printing of the journal.

Journal Committee Mr Maitlyne suggested that a title page for Vol II of the journal be printed and distributed. It was agreed that this could most conveniently be done with the next issue of the journal.

Library The librarian submitted a list of publications received. It was agreed that the exchange copy of the B.A.A. journal be kept with the Cape Centre's series in continuation thereof. It was proposed by Dr Spencer Jones, seconded by Mr Long, and agreed that the librarian and Mr Maitlyne should prepare a list of the society's library for inclusion in the next issue of Mr Lloyd's list of serial publications.

Draft Report of Council. With small additions, the report as drawn up by the secretary was agreed to, subject to additions and alterations that may be necessitated by further developments of the society's affairs occurring before the Annual Meeting.

Amendments to the Constitution. The subcommittee on the constitution suggested that the Council present the following amendments to the Annual Meeting:-

That in article II the title read "Foundation" instead of "Centres".

" - - VIII - - - "Centres and Branches" instead of "Branches" and that the following be added:- "A centre of the Society may be established at a General Meeting of the Society upon the recommendation of the Council. If such centre be formed by the entry of a previously existing organisation, all members in good standing of such organisation shall be deemed elected to membership of the society".

That in article XI "either Centre" shall read "^aany ^{Branch} Centre or Branch"

" - - XV "each of the two Centres" shall read "each Centre" and that "which two members" shall read "and These".

These were agreed to; proposed Mr Long, seconded Dr. Spencer Jones.

It was also agreed that by-law 1 be amended by substituting "any Centre or Branch" for "either Centre or any Branch". In event of the above amendments being adopted.

In the event of the ~~amendments to the constitution being passed as above~~ (and of the passage of the motion of the N.A.A. committee referred to in correspondence) it was agreed that the following be submitted to the annual general meeting as a unanimous proposal by the Council:- "That the Natal Astronomical Association be established as a Centre of the Astronomical Society of South Africa".

Nominations for Office and Membership of Council. The list of members ^{received} from the Cape Centre shewed that seventy-five members were in good standing. No list had been received from the Johannesburg Centre. Under these circumstances it was agreed to allow the Johannesburg Centre a quota of two on the Council if a late list was not received.
