ASTRONOMICAL SOCIETY OF SOUTHERN AFRICA

Minutes of Council Meeting held at the Royal Observatory on Wednesday 14th September, 1966 at 9.30 p.m.

Present: Mr. Atkins (in the Chair), Messrs. Bentley, Bondietti, Orpen, Menzies, Russo and Weinberg, and Drs. Cousins, Fuhr and Stoy.

Apologies for absence noted from Messrs Churms, Lagerweij and Meadows.

Minutes of the previous meeting held 20 June 1966 were read and confirmed.

Arising out of the Minutes

1. Mr. Bentley confirmed that the increased number of 310 copies of Sky and Telescope had been ordered from July and that accounts were being rendered accordingly. As the Secretary reported no increase in the number being received, Mr. Bentley would investigate the matter.

2. It was agreed that the Society's instruments could be loaned to suitable approved individuals or bodies on formal application to the Council, and cost of transport or damage to the instrument to be borne by the borrower. Further, after a period of 12 months, Council would consider re-newal of the loan for any further period required. The question of a fee for the use of any instrument was left for consideration at a later date. This matter is to be publicised in MNASSA for information of all members. Mr. Bentley mentioned that the Cape Centre would like the loan of the 5-inch instrument, and Dr. Stoy on behalf of the Astronomy Department of the U.C.T. asked for the McIntyre portable telescope. Mr. Atkins said that formal application should be made in writing.
