Minutes of Council meeting held on Thursday 1977 June 16 at 20h00, at the S A Astronomical Observatory, Cape Town.

<u>Present</u> Mr. Hurly (in the chair) Dr. Cousins, Dr. Wild, Messrs Bondietti, Churms, G. Larmuth, C. Larmuth, Orpen, Roberts, Russo and Turk.

<u>Apologies</u> for absence noted from Prof. Warner, Dr. Thackeray, Dr. Feast, Messrs Bentley and Simenhoff.

<u>Minutes</u> of previous meeting held 1977 May 2, which had been circulated, were taken as read and confirmed.

Matters arising (a) 15% Customs Levy. From reports it would appear that this could be of a temporary nature. In the meanwhile the Society had to pay this additional charge, although representations for exemption had been made. Mr. Duveen reported that by rights this levy should be assessed on the Domestic Value in the United States and not on the value as was currently invoiced, this including transport costs and packaging. Mr. Bentley and Mr Orpen to collaborate to get the necessary certificate from the Publishers.

Finance

Mr. Orpen presented the financial statement to date. This was adopted. It was estimated that Revenue would have exceeded expenditure by R740 at end of June. It should also be noted that the Customs Levy would only have applied for 3 months of the year.

An estimate for the coming year 1977/78 shows a credit of only R13,00. Details are given at the end of the Minutes. Mr. Orpen was empowered to place further monies from the McIntyre Award Account on Fixed Deposit up to R550.
