5. MINUTES

Minutes of previous Council Meeting held on 1990 September 24, copies of which had been circulated, were taken as read. It was proposed by Mr M.G.Soltynski and seconded by Mr P.Briton that they be accepted as a true record of the proceedings. Confirmed and signed.

6. MATTERS ARISING FROM THE MINUTES

(i) BUSINESS MANAGER: Minute No. 7(i)

Mrs A.Joubert kindly agreed to carry on as acting Business Manager ably assisted by her Mother until a replacement could be found. Council asked Mrs Joubert to convey their heart-felt thanks to her Mother.

Matters Arising From The Minutes (contd)

(ii) MACLEAR'S BOTTLE - PLAQUES: Minute No.7(iv)

Agreed to ask the National Historical Monuments Commission to design commemorative plaques to mark the sites of Maclear's and de la Caille's north terminals as fitting memorials to their efforts. Liaison with the Commission by a committee consisting of Messrs A.D.B. Cameron (convenor), P.Briton and R.Hurly. The Royal Society and the Society of Surveyors would probably subscribe to the cost of the plaques and should it be necessary ASSA would be prepared to make its contribution.

Mr R.Hurly was strongly of the opinion that a suitable article should appear in the South African Survey Journal for the record. He would contact the editor in this regard.

The possibility of an article appearing in Astronomy Now was mentioned.

(iii) NATIONAL SYMPOSIUM ON ASTRONOMY

The discussion that followed was long and involved. It was, therefore, not always possible to identify the bright objects in obscuring clouds of gas and dust. This observation does not necessarily detract from the eloquence and depth of thought that characterized the proceedings in general.

(1) Finance

It was obvious from the start that the costs involved would not be inconsiderable. The project would have to be subsidised as the income from membership fees would be inadequate. Mr C.R.G. Turk, always ready to help his fellowmen, was prepared to make a contribution from the Endowment Fund (ASSET), if necessary. Mrs E.Willis mentioned that the lecture hall at the S.A. Museum would be available at no charge.

(2) Speakers

Agreed that Professor A.P.Fairall, Professor W.Wargau and Professor Brian Warner be approached to address the Symposium. Mr M.G. Soltynski would contact Professor Wargau. It would be necessary for the President of the Society to issue the official invitations.

(3) Organising Committee

The committee consisted essentially of Dr.I.Glass and Dr.T.H. Lloyd Evans. Mrs E.Willis and Mrs A.Strauss voluntered to assist the committee when necessary.

A report is awaited from the Chairman of the Cape Centre, Mr John Davison, regarding that Centre's reaction to the Symposium.

 - (a) Mr R. Hurly proposed that the Mayor of Cape Town be respectfully asked to host a reception party on a certain night.
 - (b) It was suggested that the Proceedings should be published.

(iv) JACK BENNETT AWARD: Minute No.12

Mr C.R.G.Turk reported that he was keeping in touch with the Benett family and that Professor W.Wargau of UNISA had installed Jack's awards in a suitable place at the University.

7. FINANCE

(i) FINANCIAL STATEMENT

No financial statement was available owing to the absence of the Hon. Treasurer.

The Membership Secretary, Mrs A.Joubert, reported that the number of outstanding subscriptions had been reduced to 34. They would be reminded of their obligations in writing.

(iv) SKY AND TELESCOPE - SURPLUS STOCKS
