#### RULES

#### NAME.

The name of the Society is "The Astronomical &

The headquarters of the Society shall be at Cape Towl

#### Outrois

The objects of the Society are:

- in all its branches.
- (b) To establish an association of observers and stude

(c) To organise Observing Sections.

- (d) To disseminate current astronomical information and to encourage a popular interest in astronomy
- (e) To hold periodical meetings for the purpose lectures, the reading of papers and discussions.
- (f) To publish such matter as may be deemed adva by the Council of the Society.

(g) To form a library of astronomical literature for use of members and associates.

(h) To acquire a collection of lantern slides for a the meetings of the Society and for loan or hire; discretion of the Council.

(i) To afford members and associates not possess astronomical telescopes, the opportunity of practice observation.

## Constitution

4. The Society shall consist

(a) Of an Honorary President,

- (b) Of not more than four Honorary Vice-Presidents.
- (c) Of not more than ten Honorary Members,

(d) Of Ordinary Members,

(c) and of Associates.

#### MEMBERSHIP.

- 5. Honorary Members shall be appointed by the Council, I shall be exempt from all fees and subscriptions, but shall have right to vote at any of the meetings of the Society.
- 6. Candidates for election to membership must be proposed two members of the Society.
- 7. Candidates for election as associates must be proposed I seconded by either members or associates.
- 8. The names and addresses of candidates for election shall handed to the Hon. Secretary for consideration by the Council, to shall, if they approve, submit the candidates for election to next following meeting of the Society.

#### ADMINISTRATION.

- 9. The Society shall be governed by a Council consisting A President, two Vice-Presidents, an Hon. Secretary, an on. Treasurer, an Hon. Librarian, Directors of Sections, and ur members or associates; provided that at no time shall more an three associates be members of Council.
- 10. The Council shall be elected annually at the Annual eneral Meeting, and shall have sole management, control and sposition of the affairs, property, and funds of the Society, and tall have the power to fill, for the unexpired term, any vacancy at may occur in any of the offices of the Society, or its own body.
- 11. The Council shall meet once a quarter, or more often as ay be necessary, to transact the business of the Society. Five embers of the Council shall form a quorum.
- 12. The Council shall have power to suspend or expel any ember or associate guilty of infringement of the rules or of isconduct; provided that such person shall have the right of peal to a general meeting of the Society, at any time within tree months after such action by the Council. The decision of the eneral meeting will be final.
- 13. The Council shall have the power to frame Bye-Laws, hich shall be subject to confirmation at a general meeting of the poiety.
- 14. It shall be competent for the Council to appoint, from the to time, members of the Society residing in other centres to the as local Hon. Secretaries.

## SUBSCRIPTIONS.

- 15. Subscriptions to the Society shall be as follows:
  - (a) Members, One Guinea per annum.
  - (b) Associates, Half a Guinea per annum.
  - (c) Members and associates residing more than twenty five miles from headquarters, shall pay half mordinary subscriptions.
  - (d) Young persons under twenty years of age and students may become associates, and shall pay subscription of five shillings per annum.
- 16. All subscriptions are payable in advance, and shall become due on 1st July of each year, but anyone joining in the latter half of the Society's year, shall only be liable to half that year's subscription.
- 17. Any person being two years in arrear in payment of subscription, and failing to pay same within a month of due notification, shall cease to be a member or associate of the Society.
- 18. Any person wishing to withdraw from the Society shall give notice in writing to the Hon. Secretary, and shall pay all fees and subscriptions due.

## GENERAL MEETINGS.

- 19. The Annual General Meeting of the Society shall be held in June in each year, to receive the report of the Council the Treasurer's financial statement, and the reports from Directors of Observing Sections; to elect Officers and the Council, Directors of Observing Sections, and an Auditor, and to transact any other legitimate business.
- 20. Special General Meetings of the Society may be convened by order of the Council.
- 21. Special General Meetings shall be convened on receipt of a requisition, signed by not less than five members or associates. Notice of any such meeting must be given not later than fourteen days prior to the date thereof.

### ALTERATIONS OF AMENDMENTS.

#### VOTING.

## DISCOVERY DV A COMET.

#### LIBRARY

- 2 All books and periodicals belonging to the Society share be under the care of the Hon Librarian who shall ban them is members or associates free of charge.
- 3 Books and periodicals may only be borrowed from or returned to the Library when the Hon Librarian or some person duly authorised by him, is present.
- Any person borrowing a book or periodical must sign for the same in the book provided for the purpose.
- No book or periodical may be retained by the borrower for more than one month, and in case more than one person desires the same work such shall not be retained by any person for more than fourteen days.
- of the Hon. Librarian shall keep a list of persons desiring a particular work and shall issue it according to the priority of the names of such persons.
- Borrowers are responsible for the safe custody of works borrowed by them and must make good to the Society any loss or damage incurred in connection with such borrowing
- 8. All purchases of books and periodicals shall be made by a committee of three (one of whom shall be the Librarian) out of funds allocated from time to time by the Council for such purposes

## LANTERN SLIDES.

- The lantern slides belonging to the Society shall be under the care of the Hon Librarian who shall loan them members and associates free; provided no charge is made admission to the lecture for which they are required.
- 10. When slides are loaned for a lecture for which there is an admission charge, members and associates shall pay a fee of 1d per slide.
- Stides may be loaned to persons who are not members in associates of the Society at the discretion of the Hon Labracian, such persons shall pay a fee of 2d per slide, when a charge is made for admission to the place of exhibition, and a fee of 1d per slide it no charge is made.
- 12. All borrowers shall pay 2 to replace each slide that may be broken while in their possession.

All borrowers shall pay all charges incurred in conveying the slides from and returning to the Society's Headquarters

by hand. Should it be necessary to send by rail or post, slide must be dispatched on the day following lecture and notice of Slides must be returned to the Hon Librarian within 24 hours of the time of exhibition, provided they can be delivered dispatch posted to the Hon. Librarian at same time, 15. Should the slides be required for a second lecture ourrower must receive the sanction of the Hon, Librarian to retain them before the time at which they are due to be returned.
